R2. Reviewed the break in the stretch by #8 Regal Again (R.Shepherd), Interference to #1 Miss Flashy Mach (N.Day), no placings needed.

R3. The winner #5 P C Silent Drive (C.Clements) got loose in the winners circle and ran off the track, horse was vet checked after the race and no injuries to report.

R4. Reviewed racing in the stretch - #4 Ivegotmyeyeonu (N.Steward), over one pylon, no violations.
