Backstretch:

- Driver Nicholas Steward was in to review film with the panel this evening.
- Mr. Steward was found to be in violation of AGCO rule 22.05.01 (a), (did bear out causing interference to another horse). The violation took place at Western Fair Raceway while driving the horse E L Rock in race 9 on January 2nd 2018. E L Rock finished 2nd and was placed 3rd. Mr. Steward was assessed a 3 day driving suspension, January 13-14-15 2018. Ruling SB 49807.

R1 - All Clear

R2 – #3 Lady Of My Dream (Scott Coulter), (finished 6th) finished the race with broken equipment (lost a shoe).

R3 - All Clear

R4 – Inquiry, reviewed racing in the stretch between #1 Lady Crazy (Travis Henry), (finished 2nd) and #3 Queenofthejungle (Scott Young), (finished 4th). #1 finished 2nd and was placed 4th for causing interference to #3 in the stretch. #3 was charted with interference.

- Driver Travis Henry will be in to review film with the panel tomorrow.

R5 – Inquiry, reviewed the start of the race. #6 Idontwanabefriends (Alex Lilly), (pulled up, did not finish) suffered broken equipment before the start of the race (knee boot). #6 was a full pari-mutuel refund (amount \$4664). #6 was charted with broken equipment and an equipment break before the start of the race.

- Driver Scott Young booked of his drive in this evenings 10th race.

R6 - All Clear

R7 – Inquiry, reviewed a possible pylon violation in the last turn. #1 Tractor Glen (Justin Belanger), (finished 2nd) was inside five consecutive pylons in the last turn. #1 finished 2nd and was placed 8th for going inside three or more consecutive pylons in the last turn.

- Driver Justin Belanger was found to be in violation of AGCO Standardbred rule 18.08.02 (b) (going inside three or more consecutive pylons). Mr. Belanger was assessed a \$100 monetary penalty (first offence within a one year period). Ruling SB50470.
- Driver Jeffrey Mayhew (#7 Last Lecture) was found to be in violation of AGCO Standardbred rule 22.19 (failure to keep both feet in the stirrups).
 Mr. Mayhew was assessed a \$100 monetary penalty (first offence within a six month period). Ruling SB50356.
