- #6 Waikiki Hanover (Alfie Carroll) finished the race with broken equipment (tendon boot).

Race 4 - All Clear

- #3 Musical Spell (Alfie Carroll) finished the race with broken equipment (shoe).

Race 6 - All Clear

Race 7 - Judges Inquiry X 2 in the final quarter.

- Inquiry #1 - Possible Interference by #1 Power Engineered (Jonathan Lapointe) on #9 Kingofbrokenhearts (Alfie Carroll) around the final turn. The Judges spoke to Mr. Carroll who stated that he did have to check his horse, was impeded and lost momentum as a result of #1. Mr. Lapointe did not feel that he interferred with #9.

- Upon review of the film, #1 attempts to pull up while on the outside, which does cause Mr. Carroll to check his horse. The Judges ruled that #1 did cause interference to #9. #1 Power Engineered finished 1st and was placed 2nd.

- Inquiry #2 - Racing between #6 Master Element (Colin Kelly) and #7 Brookdale Fletcher (Travis Henry) in the stretch. It was deemed there was no interference and no placings required.

- Judges spoke with driver Scott Coulter regarding the performance of #4 Lear Seelster, the 1-2 favourite who finished 9th. He stated the bridle change from Blind to Blinkers did not work and he was having trouble steering the horse. The horse had won 3 straight races prior to tonight. Tr. Rob McMillan was not present at the track this evening. Assistant Trainer Ashley MacMillan stated the horse was looking around while on the front last week and they believed the equipment change would help the horse. Ms. McMillan said an equipment adjustment would be made for his next start.

Race 8 - Judges Inquiry at the top of the stretch between #3 Relevant (Tyler Moore), #4 Broadway Maija (Anthony MacDonald) and #6 Golden Man (Dan O'Brien).

- The back tower shows that #6 is running in on the final turn and hooks the wheel of #4 from behind. #3 is following the cover of #6 and suffers interference that causes the horse to make a break. No placings were required.

- #3 Relevant was charted with an 'ix', #4 Broadway Maija and #6 Golden Man were charted with an 'i'.

Race 9 - Judges Inquiry X 2

- Inquiry #1 - Reviewed racing at the half between #1 Creampuff Macdaddy (Anthony MacDonald) and #7 Taurus Du Parc (Nick Steward). The front tower shot shows that #1 does have ample room to move off the rail and does not cause any interference to #7. No violations. - Inquiry #2 - Reviewed the start for possible interference by #4 Lodi Dorian Blues (Robert Shepherd) on #3 Spicey Victor (Scott Coulter). #4 makes a break behind the gate and puts a wheel under #3, which the Judges determined caused #3 to change course and lose ground. #3 Spicey Victor was refunded for suffering inteference before the start. Refund \$7,648.

- #3 Spicey Victor was charted with an 'i' before the start.
