Backstretch

- David Stewart present this evening and the author of the Senior Judges Report.

- Tom Miller present this evening and held a paddock meeting with the drivers - topics included the following rules:

AGCO Rule 22.01(f) - Horses are required to parade in program order. All horses must remain in proper order until the parade has passed in front of the grandstand.
 AGCO Rule 22.05.01 - A driver shall not committ any of the following acts which are considered violations of driving rules: (e) Allow another horse to pass needlessly on the inside, or committ any other act that helps another horse to improve its position; (g)(iii) Maintain an outside position without making the necessary effort to improve his or her overall position; (i) Lay off a normal pace and leave a hole when it is well within the horse's capacity to keep the hole closed; (k) Fail to set or maintain a pace comparable to the class in which he/she is racing considering the horse's ability, track conditions, weather and circumstances confronted in the race; (m) Converse with other drivers from the forming of the post parade until released by the starter.
 AGCO Rule 22.19 - Driver shall keep both feet in the stirrups during the post parade and from the time the horses are brought to the starting gate until the race has been

completed.

AGCO Rule 22.23 - Urging Rules

- Approved trainer transfer on the horses Dial A Win and Jack Of Clubs from Travis Cullen to Garry MacDonald.

Race 2 - Reviewed the break by #2 Crystal Gumdrop (Robert Shepherd) in the 1st turn, finished 5th - no violations of the breaking rule.

- #1 Tymal Diamond (Peter Core) finished the race with broken equipment - flat tire.
