Race 1- #4 "Strike It Up" Trevor Henry was inside one pylon and over one pylon at the top of the stretch, no advantage gained, no violations

Chris Christoforou was found to be in violation of AGCO rule 22.19- drivers shall keep both feet in the stirrups during the post parade and from the time the horses are brought to the starting gate until the race has been completed. Drivers shall be permitted to remove a foot from the stirrups during the course of the race solely for the purpose of pulling ear plugs and once these have been pulled, the foot must be placed back into the stirrup- \$300 monetary penalty (2nd violation within 6 months)- SB51905

Race 2- Inquiry- #5 "Labero" Per Henriksen made a break after the start, no violation of the breaking rules

Race 3- Inquiry- #1 "Kickin Dust Up" James MacDonald was outside the fair start-refund \$13.607

#6 "Cocoa On Top" Ron Waples finished 3rd placed 5th for causing interference in the stretch to #7 "Fan The Flames" Anthony MacDonald

Race 4- Louis Philippe Roy was found to be in violation violation of AGCO rule 22.19- drivers shall keep both feet in the stirrups during the post parade and from the time the horses are brought to the starting gate until the race has been completed.
