2. Recall as while on a break before the start #5 ARDYNE SPORT (Stephane Pouliot) caused interference to #6 OHBABYOHBABYOH (Michael Armstrong). Reviewed break by #5 after the 1/4, no interference; #5 qualifies for breaks (trainer notified). Clear.

4. Driver of #9 Sylvain Lacaille invited in for a film review to discuss his urging in the stretch. Clear.

5. Inquiry after the start due to possible interference when #2 HOOTER SCOOTER (Stephane Brosseau) and #3 LDL GEM (Richard Simard) hooked wheels after the start; Mr. Simard stated that #5 ARUKIDDINMISTER (Darrell Coville) was rough after the start causing him to grab his horse and come back into the path of #2;

video did not support interference by #5 on #3. As a result of #2 and #3 hooking wheels interference was caused to #4 and #8; no placing necessary as #3 finished last (ninth). No penalty to Mr. Simard as he took hold of his horse believing #5 was going off stride. Clear.
