### Backstretch

- John Dorion is present this evening.

- Patrick Shepherd – AGCO Rule 26.12 (*It shall be the responsibility of a trainer to have the horses under his or her care, and which are programmed to race, properly equipped and in the paddock at least one hour before the scheduled post time or by the time prescribed by the track*) – Mr. Shepherd did fail to have the horse Yoooukilis properly equipped for Race 2 on April 19/18. \$100 monetary penalty, SB 49335.

- Craig Gilmour – SB 50633 – As the result of a denied appeal (SB HRAP 05021 2018), Mr. Gilmour will serve his suspension from April 29/18 – May 5/18, inclusive.

- Nick Steward excused from 3 drives

- Race 7 – #7 On Cruise Control (Tr. Scott West) was a Judges Scratch Ineligible due to AGCO Rule 35.02.06 (*After a horse is certified as a bleeder, the said horse may not race for 15 clear days from the date it was certified.*)

Race 1 – Inquiry – Reviewed possible pylon violation by #4 Twice Drafted (Scott Coulter) past the half, finished 1<sup>st</sup> – horse is inside 1 pylon and does not gain an unfair advantage. No violations of the pylon rule by #4.
