Races

Race 1 – All Clear

Race 2 – Inquiry – Reviewed racing going to the 3/4s between #1 Master Faster (Scott Young) and #6 Airway (Anthony MacDonald). The video shows that #6 does have clearance to move out of the two-hole and does not cause any interference to #1. No violations.

Race 3 – Reviewed pylons on #8 Pocket Popper (Scott Young) before the half, finished 5th – horse was not inside any pylons and hit three pylons. No violations.

Race 4 – All Clear

Race 5 – Inquiry – Reviewed #9 Xtatic Hanover (Jason Ryan) at the start – horse was ruled to not be inside the Fair Start Pole when the race started. Refund on #9 – \$10,260.

Race 7 – Reviewed pylons on #2 Fork (Brett MacDonald) at the 5/8ths, finished 3rd – horse was not inside any pylons and hit two pylons. No violations.

Race 8 – Reviewed racing around the final turn and the break by #1 Race Me Villa (Doug Bowins). #7 Matts Tuition (Scott Young) was forced inside the pylons for safety reasons to avoid #1. #7 re-enters the race course when he has clearance and finishes 5th. Judges ruled there were no pylon violations by #7 due to the interference and was charted with an 'i'.
