## Backstretch

- Driver Nick Steward was in for film reviews from April 7 and 8.
  - April 7, Race 4 Mr. Steward was found to be in violation of AGCO Rule 22.19 (*Did fail to keep both feet in the stirrups*) while driving the horse Presidents Wish. Mr. Steward was assessed a \$300 monetary penalty for his 2<sup>nd</sup> offense of AGCO Rule 22.19 within 6 months. SB 50634
  - April 8, Race 6 The Judges accepted Mr. Steward's explanation that he was having trouble with his filly (Majestic Wanda) on the turns – no further action.
- Driver Anthony Haughan did not wish to review the film from April 19, Race 5 while driving the horse Dreydl Hanover. Mr. Haughan was issued a \$100 monetary penalty for a violation of AGCO Rule 22.19 (*Did fail to keep both feet in the stirrups*). SB 50635
- Trainer transfer approved on the horse Home Matters from Travis Cullen to Michel Rivest.
- Trainer transfer approved on the horse Dont Teasetheshark from Cory Fuller to Vern Cochrane.

Race 1 – All Clear

Race 2 – Reviewed racing at the top of the stretch - #2 NJs Trick Pistol (Nick Steward) hit the final pylon at the top of the stretch and did not gain early access to the passing lane, no violations.

Race 3 – Inquiry – reviewed the break by #6 Your Raider Boy (Jason Ryan) before the start – horse was inside the Fair Start Pole at the start.

Race 4 – Inquiry – reviewed a possible pylon violation by #7 Zorgwijk Suzanne (Lyle MacArthur) past the half, finished 4<sup>th</sup> – horse was not inside any pylons and hit two pylons, no violations of the pylon rule.

- Reviewed the breaks by #5 Cape Coral (Jean Bernard Renaud), finished 5<sup>th</sup> – no violations of the breaking rule.

Race 6 – All Clear

Race 7 – Reviewed racing after the start - #8 Gotameeting (Colin Kelly) does bear in and cause Robert Shepherd (#7 Three Rockets) to check his horse. #7 was charted with an 'i' after the start; no placings were required.

Race 8 – Inquiry X 2 – reviewed racing going to the quarter.

- Inq #1 reviewed a possible pylon violation by #1 Dreydl Hanover (Anthony Haughan), finished 3<sup>rd</sup> horse was inside two consecutive pylons and not lapped at the wire, no violations of the pylon rule.
- Inq #2 reviewed the break by #2 Ciona Bromach (Michael Whelan), finished 5<sup>th</sup> the video shows that #2 jumps over a pylon that was on the track and makes a break. #2 does cause interference to #6 Mr Mach Jimmy (Scott Coulter) and #8 UF Bettors Hanover (Scott Young). #2 finished 5<sup>th</sup> and was placed 6<sup>th</sup> for causing interference while on a break. Due to the pylon on the track, #2 was charted with an 'ix', #6 was charted with an 'i', #8 was charted with an 'ix'.
- #3 New Standard (Bob McClure) pulled up at the half and must qualify for Performance. The horse was checked by Dr. Pat Meyers following the race and placed on the long-term Vets list.

- #5 Face Of War (Colin Kelly) pulled up at the quarter with broken equipment (hopple).

Race 9 – reviewed racing in the first turn between #5 Mervs Tru Legacy (Jonathan Lapointe) and #8 Blissfull Years (Dave Boughton). The two horses come together and hook wheels. #5 was charted with an 'ix', #8 pulled up before the half with broken equipment (flat tire) and was charted with an 'i'.

- #2 Val America was scratched lame by Dr. Pat Meyers after the post parade. Refund \$1,305.
- Driver breathalyzer retest race.

- Inq #1 reviewed #9 Miss M A Jones (Bob McClure) for possible broken equipment before the start. The video does not show #9 with broken equipment (overcheck) before the start.

The back tower shot shows that #6 is tipping three-wide and steps on the outside wheel of #5. No placings were required. #5 was charted with an 'i' and #6 was charted with an 'ix'.
