Trainer transfer approved for CROCADILE CANYON from Scott West to Edward McHale.

## Races:

Stephane Brosseau excused from two drives.

- 1. Judges inquiry on #3 YC EASY concerning the breaking rule before the ¾ and in the stretch. It was determined that #3 did fail to continuously lose ground while off stride; YC EASY finished fourth and was placed sixth (AGCO rule 22.27). Clear. Video: https://youtu.be/aFo4EaZjoTU
- 2. Driver of #1 WARRAWEE PROTON Brett MacDonald will be in for a film review regarding AGCO rule 22.05.01 (i) Lay off a normal pace and leave a hole when it well within the horses' capacity to keep the hole closed. Clear.
- 3. Recall as #2 ARDYNE SPORTSTAR while off stride caused interference to #3 JET GREY. #3 was not in position behind the gate and went off stride after the start; qualifies for breaks, performance and is on the starter's list (trainer notified). Clear. 4. Clear.

- 5. THE LOVE BUG was listed as #8 in the program but was drawn post position #9 and started from post position #9. Clear.
- 6. PHOENICIAN GAL #8 finished distanced with broken equipment (hopple hanger). Clear.

- 9. SENOR GRANDE #1 finished distanced, qualifies for performance; vet check after the race by the AGCO official veterinarian Dr. Atack, #1 was placed on the long term vet list (lame), trainer notified. Clear.
- 10. Both #7 COLLECTOR CLASSIC (Jacques Beaudoin) and #8 WINGS OF BALLYKEEL (Ryan Guy) failed to come into position behind the starting gate. The starter (Jamie Fiolek) will follow up with Mr. Beaudoin next Sunday. Mr. Guy was assessed a monetary penalty of \$100 for failing to come into position and remain in position behind the starting gate (AGCO rule 22.03 (j)(vii) SB 49162). Clear.
- 11.Reviewed racing going to the half following a complaint by the trainer of #1 Matthew McDonald of a slow second quarter (27<sup>2</sup> 57<sup>1</sup>); upon review there was no confusion caused to trailing horses by the leader and the second quarter was considered adequate for the class. Clear.
- 12. HOBOKEN HANOVER #3 finished with broken equipment (spreader) which the driver (Brett MacDonald) stated broke before the quarter. Clear.
