SYKES ROAD SHARK (5NR07), a gelding, is declared ineligible and disqualified from the 3rd race (Fillies & mares non-winners of \$15,000 or one race lifetime) at Rideau Carleton on 31 August 2017 (finished 8th); no penalty to the trainer (Sam Sergi) due to a problem with the USTA registration (SB 50367 AGCO rules: 5.15 (a), 11.04, 14.06 (iv) & 14.10).

Brett MacDonald excused from one drive.

- 1. Marc Andre Simoneau did cause a stable error scratch of #4 CHALLENGE MAGIC and was deemed guilty of violating AGCO rule 20.03.01 (i) and assessed a monetary penalty of two hundred dollars (second offence) (SB 50381). Clear.
- 2. Rodney LaFromboise deemed guilty of violating AGCO rule 22.03 (j)(vii) (failure to bring his horse into position behind the starting gate and remain in position) while driving #8 SPARE SEED and assessed a monetary penalty of one hundred dollars (SB 50368).
