Backstretch

- Alan Fair – \$100 monetary penalty for causing a stable error scratch of the horse Waikiki Hanover in Race 10 – AGCO Rule 20.03.01(i), 'When a horse, entered to race, is scratched by the Judges, as a result of the horse having received any: (i) medication.' SB 49341.

## Races

Race 1 – Inquiry – reviewed the break by #4 Jimmy Wintips (Scott Wray) at the start, finished 4th – no violations of the breaking rule by #4.

Race 2 – All Clear

Race 3 – Inquiry X 3

- Inquiry #1 – possible pylon violation by #4 Queenofhearts (Nick Steward) after the half, finished 4th – low pan video shows that #4 goes inside 2 consecutive pylons and is lapped by #3 Lucky Fortune (Robert Shepherd). AGCO Rule 18.08.02(a), 'If a horse while on stride, or part of the horse's sulky, goes inside two (2) consecutive

pylons, the offending horse shall be placed behind all horses that are lapped on to the offending horse at the wire.' This Inquiry was dealt with first as the violation is enforced by the lapped horse at the wire. #4 finished 4th and was placed 5th for a pylon violation. #4 was charted with an 'ip' after the half.

- Inquiry #2 – possible violation of the passing lane by #2 Vee Breeze (Scott Wray), finished 3rd. AGCO Rule 22.05.02.2, '*In the event the home stretch is expanded, (ii) the lead horse in the homestretch shall maintain as straight a course as possible while allowing trailing horses full access to the extended inside lane.*' The front tower shows that #2 bears down and takes away access of the passing lane from #4 Queenofhearts (Nick Steward), who was sitting in the two-hole. Mr. Steward did have to take a hold of his horses and was not given access to the passing lane. As a result of being in violation of AGCO Rule 22.05.02.2(ii), #2 is placed behind #4. #2 finished 3rd and was placed 5th. Following this placing, #3 finished 5 PL 4 PL 3 and #4 finished 4 PL 5 PL 4. #4 was charted with an 'i' at the top of the stretch.

- Inquiry #3 – reviewed the break by #1 Warrawee Speedy (Aaron Byron) at the start, finished 1st. No violations of the breaking rule by #1. The front tower shows that #9 Gilletle (Justin Turcotte) was following #2 and did not suffer any interference from the break by #1 and received a fair start.
