 aware of what is considered excessive when urging his horse and that any
 further violations will result in sanctions.
- Review with Guy Gagnon of race 4 from 10 June (PLAYIN FOR KEEPS) regarding AGCO rule 22.05.01 (a) (bear in causing interference); the explanation of Mr. Gagnon was partially accepted and no penalty was assigned.
- Review with Guy Gagnon of race 10 from 17 June (COBALT MAN) regarding AGCO rule 22.05.01 (k) (failure to set or maintain a pace comparable to the class); the explanation of Mr. Gagnon was partially accepted and no penalty was assigned. Mr. Gagnon was reminded of his obligations when cutting the mile and cautioned that any future violations would result in sanctions.
