- Review with Clarke Steacy from 24 June race 4 #9 TOP DESIRE concerning his
 urging in the stretch relative to AGCO rules 22.23.03 (a & b) (above head and
 past 90° relative to the track); Mr. Steacy was deemed borderline to violating
 these rules and will modify his urging style in order to be compliant with the rules.
- Review with Guy Gagnon from 21 June race 9 #8 PL JASMINE concerning his
 urging in the stretch relative to AGCO rules 22.23.03 (a & b) (above head and
 past 90° relative to the track); as the video did not clearly show the infraction no
 penalty was assessed to Mr. Gagnon, although he was cautioned.
- Trainer Michel Allard will attend the Judge's office for a review concerning having unauthorized prescription medication in his possession.
- Met with the General Manager Peter Andrusek and the AGCO official veterinarian Lynne Blackburn regarding extreme temperature protocols (Tier 1) to be emplaced for 1 July at Rideau as Environment Canada forecasts a high temperature of 36°C.
