Trainer of REBEL CHILD, Gavin Christie, was assessed a monetary penalty of \$100 for causing this horse to be scratched from the 7th race due to a stable error in violation of AGCO rule 20.03.01 (a) (SB 50374).

Races:

- 1. Inquiry on #6 CLASSIC SCARLET (Justin Turcotte) before the ¼ mile pole; #6 did cause interference to #4 DUNE SPEED (charted with an interference break) and #1 TANZANIAN (charted with interference) while off stride; no placing necessary as #6 finished last (6th). Clear.
- Driver of #1 DAM LUCKY, Reg Gassien, was adjudged guilty of violating AGCO rule 22.05.01 (k) (failure to set or maintain a pace comparable to class) by going a second guarter in 31 4/5 seconds and assessed a monetary penalty of \$100 (SB 50375). Clear.
- 3. Driver of #8 FIRST KISS, Doug Hie, stated that his horse made a break after the 3/4 mile pole; video review did not confirm that his horse broke; #8 must qualify for time (2:02:2) and is on the Starter's List (trainer notified). Driver of #5 HAZUSEENMYBUCKET, Justin Turcotte, was adjudged guilty of violating AGCO rules 22.23.01 (b) (excessive urging) and 22.23.03 (a & b) (hand above head and beyond 90° relative to the track) and assessed a three day driving suspension (to be served 4-6 August, inclusive) and a \$200 monetary penalty

(SB 50376). Clear.
