Inquiry on #3 CHOSEN HOMBRE (Nick Boyd) concerning possible interference before the ¾ mile pole when #3 appears to touch the wheel of #8 ITS MACHADEMIC (Doug Hie); Mr. Hie stated that #3 did touch his wheel while trying to attain a position off the rail; the driver of #1 MAGNIFY BLISS (Jason Woodward) stated that he was interfered with when #3 slowed suddenly after touching the wheel (#1 charted with an interference); #3 finished 1st placed 5th for causing interference to #1 (AGCO rule 22.09). Mr. Boyd will attend the Judge's office for a review concerning AGCO rule 22.05.01 (h) (strike or hook wheels with another sulky). Clear.
