- Certificate of Positive Analysis from 4 August race 8:
 - Horse: TALKING BOOK (3DB34) who finished 3rd, Tag # 42 18216 010 (blood)
 - Drug: methylprednisolone (class 4)
 - Trainer: Brenda Lane.
- Review with driver Nick Boyd from 18 August race 3 regarding AGCO rule 22.05.01 (h) (strike another sulky) while driving #3 CHOSEN HOMBRE; the panel partially accepted the explanation of Mr. Boyd concerning penalty but not regarding the fact that his actions had caused interference to #1 MAGNIFY BLISS as it is the responsibility of a driver to have control of his horse at all times; no penalty.
- Review with driver Ryan Guy from 18 August race 9 regarding AGCO rules 22.23.01 (b) (excessive) and 22.23.03 (a & b) (above head and beyond 900 relative to the track); the panel partially accepted the explanation of Mr. Guy who is now fully aware of what constitutes allowable urging and the penalty for violation, no penalty.
