Report on day's events:

Office:

- MONTANA BEN a Judge's scratch (ineligible) from the 5th race, AGCO rule 11.02.02 (f) (lacking a clean line within 45 days at an extended meeting).
- Driver Jacques Beaudoin attended the Judges office for a review of his urging in the stretch of race 10 on 5 August while driving LMC MASS GEM related to AGCO rules 22.23.03 (a & b) (above head and beyond 90° relative to the track); Mr. Beaudoin is now cognizant of the urging limits, and the penalty for breaching these limits, and will modify his technique; no penalty.

- Melanie Plourde excused from one drive.
1. Inquiry on #9 LESTENPERCENT (Paul LaFromboise) who finished 5th in the last turn concerning AGCO rule 18.08.02 (leaving the course), #9 hit several pylons and was inside two consecutive pylons but was not lapped, no placing.
Cautioned driver Rosaire Renaud (#2 YA MUSCLE MASS) who finished 6th concerning AGCO rule (j) (careless) by driving up on the driver of #5 UNSINKABLEONE who finished 4th Matt Harvey, no placing required. Clear.

4. Reviewed break by #4 CURTAIN CALL (Jacques Beaudoin) who finished 5th after the ¼ mile pole; driver of #6 LEADER TONIGHT, Stephane Brosseau, who finished 2nd stated he did not suffer interference. Clear.

Inquiry on #5 SHHH ITS A SECRET (Jonathan Lachance) broke after the ¼ mile pole and pulled up with broken equipment (front hopple hanger) after contacting the wheel of #9 BEST TO HURST (Brett MacDonald) while leaving the pocket and subsequently causing interference to #8 SMALLTOWN TERROR (Ted McDonald) (charted with an interference), no placing required as #s 9 and 8 finished 1st and 2nd, respectively; #5 was charted with an interference break due to contact with the wheel of #9 and broken equipment.
