Report on day's events:

1. Review with driver Richard Simard of race 3 from 13 September regarding AGCO rules 22.05.02 (ii) (passing lane) and 18.08.02 (leaving the course); Mr. Simard was adjudged guilty of violating these rules and assessed a monetary penalty of \$100 (SB 50394).
