Race 1 – All Clear

Race 2 – All Clear

- #6 Spectrum Seelster (Travis Cullen) broke a hopple hanger and then made a break. The horse was charted with an equipment break.

Race 3 – Inquiry X 2

- Inquiry #1 – Reviewed the breaks by #3 Mercedes Titan (Bob McClure), finished 5th, and #5 Teddys Littleangel (Paul MacDonell), finished 3rd, in the final quarter mile. Both horses were ruled to have followed the breaking rules, no violations.

Page 2 - Inquiry #2 – Reviewed the break by #7 Angel For Life (Chris Christoforou) before the start – the horse was deemed inside the Fair Start Pole.

Race 4 – Inquiry – Reviewed possible passing lane violation by #2 Casimir Rumrunner (Paul MacKenzie) in the stretch, finished 2nd.

AGCO Rule 22.05.02.2 reads, 'In the event the home stretch is expanded pursuant of subsection (a), the following shall apply on 1/2 mile tracks: (ii) the lead horse in the homestretch shall maintain as straight a course as possible while allowing trailing horses full access to the extended inside lane.'

The Judges Inquiry reviewed to see if #2 Casimir Rumrunner gave full access to the extended inside lane to #4 Ateyatefngerslouie (J Bradley Harris).

The front tower shot shows that #2, the lead horse, drifts into the passing lane and does not give full access to #4. As a result, the Judges determined that #2 was in violation of AGCO Rule 22.05.02.2(ii) and would be placed behind #4. #2 Casimir Rumrunner finished 2nd and was placed 4th for interference by not giving trailing horses full access to the extended inside lane. MacKenzie will be in for a film review.

Race 6 – Reviewed the break by #5 Briarwood Belle (Rick Zeron) in the first quarter, finished 5^{th} – the Judges ruled that #5 broke on her own and did not violate any of the breaking rules.

Race 8 – Reviewed possible pylon violation by #4 Brandon Hanover (JR Plante) coming to the half, finished 5th. The front tower video shows that #4 goes inside three consecutive pylons. #4 finished 5th and was placed 8th for a violation of the pylon rule.

- #4 was checked by AGCO Vet Dr. Pat Meyers following the race and reported OK. The horse was put on the Judges List and must qualify for Performance.

Race 11 – Inquiry – Reviewed racing in the stretch between #1 Uptown Woman (Travis Henry) and #7 Honor Roll (Travis Cullen). The front tower shows that horses are drifting out together in the stretch. The pan shot shows that #1 is clear of #7 and does not cause any interference. Mr. Cullen stated that he was not bothered. The Judges ruled that #1 did not interfere with #7 and no change was made to the order of finish.
