Race 4 – Inquiry – Reviewed racing going to the quarter - #5 Lyons Amusements (LP Roy) makes a break and causes #7 Lively Larry (James MacDonald) to make a break. #9 Northern Sportsman (Jody Jamieson) is behind the two horses and moves to the rail to avoid them, and comes together with #3 Bring It Home Will (Wayne Dunn). #1 Smart Thinking (Jonathan Drury) goes inside pylons to avoid horses. The Panel ruled that the break of #5 caused confusion to #s 1, 3, 7, and 9 and those horses were charted with interference. #7 was charted with an ix. No change was needed to the order of finish.
