Report on day's events:

Office:

- CRAVEN THE BEACH was a Judge's scratch (retention) from the 1st race as this horse did not receive Lasix within the prescribed time period (AGCO rule 35.07.07); the explanation of the trainer (Matthew McDonald) was accepted by the panel and no penalty imposed.

Races:

- Richard Simard excused from seven drives.
 - Clarke Steacy excused from one drive.
1. Driver Emil Toth will attend the Judges office for a review regarding his urging past the ¾ mile pole and in the stretch while driving #1 MITT JAGGER. Clear.

 3. SUN OF A SHOW #5 suffered broken equipment (lost a shoe) past the ½ mile pole and finished with broken equipment. Clear.
 4. Participants in this race lodged a complaint that #2 RAISING RICHARD did not fit the condition (NW \$400 per start last 10 starts); the horse was allowed to race under protest (AGCO rule 23.03). After the race had been contested, the race office confirmed that the condition had been changed and should have read NW \$470 per start and thus RAISING RICHARD was eligible.

Before the ½ mile pole #4 MONTANAALASKA (Jonathan Lachance) broke and fell; no injuries to the driver and only minor abrasions to the horse; #4 qualifies for performance

(trainer notified). Clear.
