#### Office:

- Rodney LaFromboise has been upgraded to a driver A licence.
- In the first race the claiming price of \$10,000 on #4 PROFOUND PATIENCE was omitted from the program. This information was announced prior to the race.

#### Races:

- Gilles Gendron excused from one drive.
1. Clear.
  2. Cautioned the driver of #3 COOL HAND LUCAN, Claude Cadieux, concerning his urging in the stretch. Clear.
  3. Clear.
  4. Reviewed racing after the ¼ mile pole where the horses bunch up after #3 ROSE RUN SLIDER (Jonathan Lachance) drives up on #4 OK JASMINE (Stephane Pouliot); no violations. Clear.
  5. Late Judges scratch (ineligible) of #4 TOPVILLE CHROME, refund: \$38.

Inquiry on #1 BETTER NOW (Pascal Berube) who, while in front at the top of the stretch, bears in and does not allow #5 BEACH RUNNER AM (Marie-Claude Auger), who finished 5<sup>th</sup>, full access to the passing lane; #1 finished 4<sup>th</sup> and was placed 5<sup>th</sup> (AGCO 22.05.02.2(ii)); no penalty to Mr. Berube as the horse was visibly on one line. Clear.

7. Inquiry on #7 STONEBRIDGE HALL (Pascal Berube) who broke before the ¼ mile pole and finished first, concerning the breaking rule; no violations by #7.

Reviewed break by #2 RAISING RICHARD (Stephane Brosseau) after the start; while off stride #2 did cause interference to #5 AJ DESTINY and #6 FOUR STARZ SPEED; no placing necessary as #2 finished last (7<sup>th</sup>); #2 qualifies for breaks (trainer notified). Clear.

8. Driver of #8 AMERICAN ASSASSIN, Donald Jobin, will attend the Judges office to provide an explanation concerning the performance of his horse who finished 2<sup>nd</sup>. Clear.

10. Late Judges scratch (ineligible) of #2 KINDA LIKE HER, refund: \$35. Clear.
11. Late vet scratch (lame) of #5 CHEYENNE MOISHE by the AGCO official veterinarian, refund: \$5277. Driver of #8 LOOKIN ATA WINNER, Stephane Lareau, will attend the Judges office regarding failure to keep the hole closed before the ¼ mile pole and his urging in the stretch. Clear.
12. Inquiry on #1 IFIHADABRAIN (Karl McFarland) who broke before the ¼ mile pole; while off stride #1 did cause the drivers of #4 SLIP INTO GLIDE (Pascal Berube) and #7 FLYING ISA N (Stephane Brosseau) to suddenly grab their horses causing interference to #4 and an interference break to #7; #1 finished 4<sup>th</sup> and was placed 7<sup>th</sup> (AGCO rule 22.09).
