Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Donald Jobin accepted responsibility resulting from the positive test for phenylbutazone and its metabolites (class 4) from VINTAGE MUSCLE who raced in the first race on 26 May (Tag # 4519146002). Mr. Jobin accepted a settlement agreement and will be fully suspended for five days to be served 24-28 June (SB 50945).
- Driver Marie-Claude Auger attended the Judges office for a review concerning her failure to keep a hole closed with OXFORD COMMA from the 8th race on 13 June. The panel partially accepted the explanation of the participant but did emphasize that more effort was expected on her part to keep the hole filled and not allow another horse easy access; no penalty.

Races:

1. Clear.
2. No video replay for this race due to technical complications. Clear.
3. Spoke with driver Guy Gagnon concerning #6 BIG YELLOW who broke before the ¼ mile pole and paced thereafter; Mr. Gagnon was instructed that as his horse was not trotting he is required to make every effort to have the horse regain it's gait and not allow the horse to pace for the remainder of the mile. Clear.
4. Late Judges scratch (other) of #5 MISSTWINKLINSJONES; refund: \$15. Clear.
5. Clear.
6. Recall as #2 COLLECTOR CLASSIC (Jacques Beaudoin) broke before the start and

did cause interference to #9 MUSCLE LANE (Matt Harvey) before the start.

Inquiry on performance of #2 COLLECTOR CLASSIC (Jacques Beaudoin) who broke before the start and did cause interference to #9 MUSCLE LANE (Matt Harvey) before the start; #2 finished 8th and was placed 9th (AGCO rule 22.09); refund: \$1463. Clear.

7. Late scratch of #8 AMERICAN LEGEND (lame) by the AGCO official veterinarian, who placed #8 on the Vet list (7 days); refund: \$59.

Inquiry after the ¼ mile pole concerning possible interference; #7 MOHEGAN BLUE CHIP (Mike Healey) drives up on #5 DABUNKA (Jacques Beaudoin) and breaks stride, no violations; Mr. Healey reported that #7 suffered broken equipment after the start (lost a shoe), which was unable to be verified by video review, and finished with broken equipment; #7 qualifies for breaks (trainer notified).
