## Office:

- Review with Jonathan Lachance from race 3 on 12 September while driving of #9
  VEGAS RICH concerning AGCO rule 22.05.01(i) (leave a hole when it is well within the
  horse's capacity to keep the hole closed); the explanation of the participant was
  partially accepted and no penalty was assigned, although Mr. Lachance was cautioned
  regarding any further infractions of this rule.
- Report received that at the conclusion of race 6 on 12 September, when the horses were in the backstretch, Pierre-Marc Longpre did enter the track, pursue the driver of #7 ARRHYTHMOGENIC, Daniel St. Pierre, and verbally berate this individual. Mr. Longpre will attend the Judges office regarding his conduct.

## Races:

- Clarke Steacy excused from five drives.
- Ted McDonald excused from one drive.
- 1. The ephoto (photo finish) was not available due to a computer malfunction; the video of the race was reviewed to confirm the order of finish and it was announced that the Judges decision was final (AGCO rule 5.12(e)). Clear.
- 2. Clear.
- 3. Reviewed the performance of #6 SOMETIMES WHEN (Stephane Pouliot), who finished 2<sup>nd</sup>, before the ½ mile pole; #6 did make a misstep but did not break stride, no violations. Video unable to be uploaded due to connectivity issues with the internet for the Association.

- #7 TALBOTCREEK SUZIE (Pascal Berube) suffered broken equipment (martingale) before the ½ mile pole and finished with broken equipment. Clear.
- 4. Inquiry on #6 ARSENAL DE CHAFRA (Guy Gagnon) regarding leaving the course after the ¼ mile pole when #6 goes inside #1 GRINGO STAR (Anne-Marie Turenne); Mr. Gagnon stated that #1 pulled out and he went up the rail, Ms. Turenne stated she did not move out and allowed Mr. Gagnon to take the space for safety reasons; video review indicated that #6 did enter the passing lane, thereby leaving the course, and gain an unfair advantage; #6 finished 3<sup>rd</sup> and was placed 7<sup>th</sup> (last) pursuant to AGCO rule 18.08.02(b). Video unable to be uploaded due to connectivity issues with the internet for the Association. Mr. Gagnon was adjudged guilty of violating this rule and assessed a monetary penalty of \$100 (SB 50968).

Driver of #1 Anne-Marie Turenne cautioned regarding her urging after the ¾ mile pole and in the stretch.
