#### Office:

- Educational review regarding urging with driver Stephane Pouliot concerning the horse DINNER AT THE MET from the 8<sup>th</sup> race on 15 September; upon reviewing the video, Mr. Pouliot recognized that he was using more than acceptable wrist action and will modify his technique to comply with the urging rules; no penalty but the penalty structure for urging violations was discussed.
- Reviewed the video of the 6<sup>th</sup> race on 12 September with driver Daniel St. Pierre concerning his objection (disallowed) against #9 BLACK ELEKTRA (Marie-Claude Auger); upon review Mr. St. Pierre accepted that #9 did not bear out and interfere with his horse.

### Races:

- Numerous Judges scratches (retention) due to a fatal accident causing highway 417 to be closed for an extended period and traffic rerouted. No penalty to the trainers of these horses.
- 1. DECRET JUSTICIALE #3 scratched Judges (retention), refund: \$20. Clear.

- Inquiry on the break by #6 VINTAGE MUSCLE (Donald Jobin) after the start concerning the breaking rule and possible interference to #9 SPARE SEED (Jonathan Lachance); no violations.

Inquiry on breaking horses (#1 MONTANABLACKANGEL, #6 ORLYS PRIDE & #7 POCKETFULLOFDREAMS, who finished third, first and second, respectively) after the start concerning the breaking rule; no violations. #1 and #6 qualify for breaks (trainers notified). GOALTENDER #2 broke before the start and was well inside the fair start pole when the starter released the field and did receive a fair start.
