Report on day's events:

Office:

- Educational review with driver Matt Harvey from the ninth race on 19 September (#5 MIDNIGHT PLAY) in the stretch; upon reviewing the video, Mr. Harvey recognized that he was using more than acceptable wrist action and will modify his technique to comply with the urging rules; no penalty but the penalty structure for urging violations was discussed.
- Discussed the Judges scratch of BETTOR JET from the fourth race at Kawartha on 21 September, explanation of the trainer, Sam Sergi, was accepted.

- 1. Reviewed the break by #1 GA SPEED JOEY (Guy Gagnon) before and after the start and before the ¼ mile pole; no violation of the breaking rule; discussed the performance of this horse with the driver, the trainer will make the necessary adjustments for the next race. Clear.
- 2. Recall due to broken equipment (bridle) on #4 ZARCONIA SEELSTER (Robbie Robinson). SIR DALI #6 suffered broken equipment (knee boot) at the ¾ mile pole and finished with broken equipment. Clear.
- 3. Driver of #5 AUDI BAYAMA, Yves Filion, was cautioned regarding using more than acceptable wrist action when urging. Clear.
