Report on day's events:

Office:

- Review with driver Mike Healey and trainer Matthew McDonald of the first race from 21 November regarding the #6 BADSTORMANYPORT. Mr. Healey was adjudged guilty of violating AGCO rule 22.05.01(h) (strike or hook wheels with another sulky) an assessed a three day driving suspension to be served 15-17 December (SB 50981).

 - Clarke Steacy excused from three drives.
1. Late scratch (lame) of #3 SIR DALI by the AGCO veterinarian, refund \$83. Clear.

 3. Due to ROCKABELLA (ineligible) being removed from the program in error, #9 WHATS MY NAME was moved listed as position #8 but did start from post position #9. Clear.

Mr. Voyer was adjudged guilty of violating AGCO rule 22.05.01(h) (strike another sulky) and assessed a three day driving suspension to be served 27-29 November, inclusive (SB 50975). Clear.
