### RACES

R1 – Inquiry on the start. #4 Five Run Homer (A. MacDonald) broke before the start and looked to be bearing in on #3. The review showed that there was no interference, all horses received a fair start and there was no violation of the breaking rules by #4. #3 Gym Socks (C. Kelly) fell out of contention during the race and was distanced at the finish. #3 must qualify for “performance”.

R2 – Clear

R3 - #1 Major Comfort (A. Sorrie) hopped over a broken pylon at the head of the stretch. Finished 5<sup>th</sup>, did not break stride but charted with interference (i). #2 Julian I Am (J. Ryan) shows as a “colt” in the program but the trainer informed us that the horse is a gelding. The public was notified and SB CAN was updated.

R8 – Reviewed possible pylon violation after the ½ by #3 Evas Best Girl (C. Kelly) who finished 4<sup>th</sup> and was not lapped on by another horse at the finish. #3 was inside one pylon and over one pylon, no violation.

R9 – Inquiry on #1 Julio Lauxmont (J. Ryan) who had a broken bar bit before the start and finished 4<sup>th</sup>. A pari-mutuel refund of \$2,409 was returned to the public as the horse had broken equipment (be) before the start.

R10 – Inquiry on #1 Shes a Bentley (C. Kelly) for possible pylon violation in the last turn. Kelly was forced down and inside two pylons and not lapped on by another horse at the finish. No violation. #7 Voleur de Banque (B. MacDonald) lost a shoe during the race and was charted with broken equipment (be). The drivers in this race received a breathalyser retest.
