Race 1 – #7 All Out Henry (Travis Henry) finished the race with broken equipment (shoe). Race All Clear.

Race 2 – All Clear

Race 3 – Inquiry – Reviewed possible pylon violation by #2 Incredible Hally (Stephen Charlton) at the top of the stretch, finished 4th. The front tower video shows #2 races inside two consecutive (red) pylons and is lapped at the finish by #7 Olympic Glide (Alfie Carroll). #2 finished 4th and was placed 5th for a pylon violation.

Race 4 – Inquiry – Reviewed the start for possible interference – #2 Montecarlomuscles (Brian Dunbar) makes a break before the start and causes interference to #8 American Pageant (Aaron Byron). #8 was refunded for suffering interference before the start and charted with an 'ix'. Refund \$2,178.

Race 5 – Inquiry – Reviewed break by #6 Top Royal (J Bradley Harris) in the stretch, finished 3rd – no violations of the breaking rule.

Race 6 – Reviewed #6 Flic Flac Flanagan (Bruce Richardson) in the first turn, finished 3rd – the horse got rough but did not make a break. #6 finished the race with broken equipment (brace bandage).

Race 7 – Reviewed the break by #2 Bidfora Hug (Nick Boyd) after the half – #4 Ride Away Shark (Travis Henry) and #10 Miss Brandi K (Scott Coulter) were charted with interference.

Race 8 – Inquiry X 2

- Inquiry #1 Reviewed possible pylon violation by #6 Windsong Ophelia (Nick Steward) at the top of the stretch, finished 3rd. The front tower video shows #6 goes inside the red pylon leading into the passing lane. AGCO Rule 22.05.02.2 (iii) reads, 'Horses using the open stretch must first have complete clearance of the pylons.' By going inside the pylon #6 did not have complete clearance to use the passing lane and was ruled to have gained an unfair advantage on #7 Red Hot Torch (Robert Shepherd), who was to his outside. #6 finished 3rd and was placed 4th for a pylon violation.
