Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Early vet scratches (sick) of THE SEASHADOW from the first race, KEYSTONE NOLAN from the third race and OK DIABLO from the fifth race by their trainers.
- Resulting from the withdrawal of his appeal of SB 50981 wherein Mike Healey was issued a driving suspension of three (3) days and BADSTORMANYPORT who finished 1st, was placed 6th for an interference violation in the first race at Rideau Carleton Raceway on 21 November 2019, in accordance with AGCO rule 22.05.01(h) (strike or hook wheels with another sulky) (SB HRAP 05033 2020), the driving suspension to Mr. Healey is hereby reinstated and will be served 25-27 July, inclusive (Ruling 1042573).
- Discussed COVID-19 protocols with Racing Manager Peter Andrusek regarding the nine Ontario Sires Stakes races scheduled for Sunday 26 July.
- Post time for the first race delayed until 1610 hours at the request of the Association.

Races:

- Clarke Steacy excused from three drives.
1. Reviewed the performance of #4 PREVIEW DE VIE (Claude Cadieux) around the last turn; #4 did contact three consecutive pylons but did not leave the course, no violations. Clear.

 4. ORLYS PRIDE (Richard Simard) #5 suffered broken equipment (knee boot) at the ¼ mile pole and finished second with broken equipment. Clear.

5. Reviewed the performance of #7 OXFORD COMMA (Ryan Guy), who finished third, in the last turn; #7 did go inside one pylon, no advantage gained and no violation. Clear.
6. Inquiry on #5 ADAM BAYAMA (Yves Fillion) who finished third concerning the breaking rule; #5 did break after the ¼ mile pole, no violation of the breaking rules. Clear.

7. Late Judges scratch (transportation) of #6 FRIDO PV, refund: \$134. Reviewed the performance of #7 STPATTYSDAY (Tyler Jones), who finished fourth, before the start; #7 did pace, switch to the trot at the fair start pole, but did not come into position behind the gate and was charted with a break before the start; #7 was inside the fair start pole when the starter released the field and did receive a fair start. Clear.
8. Late Judges scratch (injured) of #1 AMERICAN LEGEND, refund: \$125. LARRY IS DEBS ROCK (Richard Simard) #5 suffered broken equipment (shoe) after the ½ mile pole and finished second with broken equipment.

Inquiry concerning the break by #3 MOHEGAN BLUE CHIP (Guy Gagnon), who finished fourth, in the stretch; #3 was back on stride at the finish and did lose ground while off stride, no violation of the breaking rules. Clear.
