Details:Driver of #5 PASSIONATE PRINCE, Jacques Beaudoin, was adjudged guilty of violating AGCO rule 22.23.03 (b) (more than acceptable wrist action) and assessed a monetary penalty of \$200 and a driving suspension of three days (15-17 September, inclusive) (Number 1068852). Clear. / Variant:0.

## Race 6

Details:Inquiry on the performance of #9 STAGE TERROR (Darcy Clancy) who broke before the start and had not reached the fair start pole when the starter released the field; full refund of \$2,388 (AGCO rule 22.03(l)). #9 was examined by the AGCO veterinarian after the race who reported the horse to be asymptomatic. Details:Reviewed the performance of #5 ORLYS PRIDE (Richard Simard) before the 1/4 mile pole concerning leaving the course; #5 did contact one pylon and was inside one pylon; no advantage gained and no violation. Clear. / Variant:0.

Details:Driver of #3 ARRHYTHMOGENIC, Daniel St. Pierre was adjudged guilty of violating AGCO rules 22.23.03(b)(c)(d) (more than acceptable wrist action, outside the confines of the sulky & below the shaft of the sulky, respectively) in the stretch and was assessed a monetary penalty of \$200 and a driving suspension of three days (15-17 September, inclusive) (Number 1068890); #9 was examined by the AGCO veterinarian after the race and found to be in good condition.
