## STAND

- Second Leg of the Harvest Series for 2YO Colts & Geldings Pacers and Trotters.

- Approved Trainer Transfers on the horses National Sport and Curious Cortez from Jared Bako to Richard Moreau.

- Judges spoke to Trainer Joe Pereira regarding a Change of Performance with the horse Lyons Girlhanover from R2 on Friday October 23. Mr. Pereira stated he has had the horse for three months and she chokes off very easy in the race, as was the case on August 28<sup>th</sup> when she was put on the Judges List. Last Friday was the first time they tried a double tongue-tie and raised her head higher in hopes it would help. Jay Harris was able to make the front and let her roll on the lead, and she responded well to the changes. Her start October 1st was a big mile at Flamboro and on October 15<sup>th</sup> she was taken off the gate from an outside post and closed well. Judges will monitor the horse going forward.

## RACES

Race 1 – All Clear

- #4 Mohegan Blue Chip finished the race with broken equipment (side hopple hanger).

Race 2 – Inquiry X 2 – Reviewed racing in the stretch and a possible urging violation in the third quarter.

Page 2 - Inquiry #1 – Reviewed racing in the stretch between #2 All Cheddar (Mike Saftic) and #8 Shazam Blue Chip (Bob McClure). The front tower video shows #8 drifts out in the stretch and causes interference to #2. #8 finished 2<sup>nd</sup> and was placed 3<sup>rd</sup>. No penalty to McClure as the horse is visibly bearing out.

- Inquiry #2 – Reviewed racing around the final turn for a possible urging violation by #2 All Cheddar (Mike Saftic). The apex tower and low pan video shows Saftic places both lines in his left hand and urges the horse with his right hand. As per Policy Directive No. 5-2009, 'for an offence where a driver has driven with both lines in one hand and struck the horse with the whip, the Judges shall place the horse last.' As a result, #2 who finished 3<sup>rd</sup>, placed 2<sup>nd</sup>, was subsequently placed 7<sup>th</sup>.

- Saftic – \$200 monetary penalty and 3-day driving suspension (Nov 2, 3 & 4), AGCO Rule 22.23.04(a), Ruling #1097896.
