Report on day's events:

Office:

- Resulting from a Certificate of Positive Analysis quantifying cobalt (Class 3) at 145 ng/mL (above the allowable limit of 100 ng/mL) in the official urine sample (Tag # 45 20310008) obtained from the race winner PL GYRO (0HM01) of race 6 on 5 November at Rideau Carleton, Andre Champagne (trainer) has entered into a settlement agreement regarding violation of AGCO rules 9.09(b), 26.02.01, 26.02.02, and 26.02.03(c). Mr. Champagne is fully suspended for a period of forty-five (45) days (2 January to 15 February 2021, inclusive) and assessed a monetary penalty of five hundred dollars (\$500) (Number: 1125461).
- Early Judges scratches of STAR DOG (transportation) from the first race, SEE YOU
 MEN (injured) from the fourth race, ASHLEYSBEST (other) from the fifth race and
 WRANGLER CASH (other) from the sixth race.
- Early Vet scratches of DR SPENGLER (sick) from the fourth race and BALI (lame) from the fifteenth race by their respective trainers; both entered on the short term (7 day) vet list.

- Ted McDonald, Daniel Laflamme & Steeven Genois each excused from one drive.
- 1. Cautioned the driver of #9 STILETTO BLUE CHIP, Pascal Berube, regarding not keeping a hole closed when it was within his horses' capability to do so. Clear.

2. Inquiry and driver's objection by #9 PERFECT DALIANCE (Jonathan Lachance), who finished third, against #1 SHANGHAIGOLD (Marie-Claude Auger), who finished second, in the stretch; Mr. Lachance stated that #1, who was in front, failed to yield the passing lane; Ms. Auger stated that she had tried to keep her horse out of the passing lane but could not; #1 finished second placed third (AGCO rules 22.05.02.2(ii) (allow trailing horses access to the passing lane) & 18.08.02 (leaving the course)). No penalty to Ms. Auger as her horse was clearly bearing in and she did attempt to maintain a straight course in the stretch. Clear.
