- Inquiry concerning possible interference between #2 TWO FOR TRIPPING (Pascal Berube), who finished fourth, and #5 BRONSON (Stephane Brosseau) before the ½ mile pole; #5 broke before the half mile pole causing interference to #2 who was charted with an interference break; no placing necessary as #5 finished ninth (last). Clear.

- 2. SAGALI #2 finished distanced and must qualify for performance (trainer notified).
- <u>No contest</u>. At the ¼ mile pole #1 SIR CHOPIN (Carol Voyer), who was cutting the mile, hooked wheels with #7 SEEYOU MEN (Guy Gagnon), who was first over on the outside, causing both horses to suddenly slow and resulting in #4 ITS HUW YOU KNOW (Mike Healey) contacting the sulky of #1, causing an accident and resulting in Mr. Healey being unseated and laying motionless in the passing lane and the #4

running loose; the emergency lights and siren were activated and the race declared no contest (AGCO rule 22.23.02). Refund: \$28,617.

#4 was examined by the AGCO veterinarian who reported only a small scrape on the right hock. Mr. Healey reported a sore back when examined by the Rideau Carleton EMS personnel and was excused from his drive in the fourth race.

Mr. Voyer will attend a review regarding AGCO rules 22.05.01(a, b & h) (bear out into another horse; impede the progress of another horses; hook wheels with another sulky).
