  consecutive veterinary scratches AGCO rule 20.04.03) from the second race,
  SPORTS BLISS from the third race and LAA DEE GAA from the eighth race; these
  horses are entered on the short term (seven days) veterinarians list.
- Early Judges scratches of SKY SPIRIT (transportation) from the second race and STELLA ALPHA (other) from the eighth race.

#### Races:

- Phillip Reid excused from two drives.
- Pascal Berube and Paul LaFramboise each excused from one drive.
- 1. Inquiry concerning the break by the race winner, #9 SCARLETTS BIGBEACH (Guy Gagnon), before the ¾ mile pole; no violation of the breaking rules by #9.

Reviewed the break by #2 WATCH US PARTY (Stephane Brosseau) after the ¾ mile pole; while off stride #2 did cause interference to #8 RITCHIE ALPHA (Steeven Genois); no placing necessary as #2 finished behind #8.

Reviewed the last turn concerning a complaint by the driver of #6 WELLWORTHTHEWAIT, Brian Scott, that #3 JIMS BIG THRILL (Mike Healey) had

forced #2 wide and driven up the inside, which was not supported by the video; #3 took the space allowed when #6 went wide; no violations. Clear.
