- Early Judges scratches (injured) of THRILLING TIMES from the seventh race and WOO SHARK from the eighth race by the AGCO veterinarian Dr. Melissa Rocheleau.
- Early Judges scratch (ineligible) of MACH TIE SON in the ninth race as this horse was claimed prior to entry and the new owner elected not to race (AGCO rule 15.06).
