#### Office:

- One division of Ontario Sire Stakes gold, and three divisions of grassroots, for three year old trotting colts.
- Review held with Drew Smyth regarding an altercation in the paddock on 19 June. Mr. Smyth was adjudged guilty of violating AGCO rules 6.17(b) (threaten another person) and (d) (engage in improper conduct) and was assessed a \$200 monetary penalty and full suspension for a period of 7 days (seven days stayed) (Number 1792277). Any conduct violations relating to AGCO rules 6.02 or 6.17 within one year of the ruling date will result in immediate reinstatement of the stayed portion of the penalty along with any additional penalty imposed by the Race Officials.
- Review held with driver Marie-Claude Auger concerning JOBAVA HANOVER in the third race on 7 July, who finished second. After reviewing the race video, previous races when this horse was driven by the participant, speaking with trainer Andreane Poirier and considering the explanation provided by Ms. Auger, no regulatory action is required.
