- Early Veterinary scratch (sick) of PEANUTBETTORNJELLY from the fourth race; this horse is entered on the short term (seven days) veterinarians list.
- Early Judges scratch (transportation) of SWEET MONEY HONEY from the ninth race.
- Early Judges scratch (injured) of ALS WARRIOR from the ninth race.

- Tyler Borth excused from two drives.
- 1. Reviewed breaks by #1 ANGLIC KT (Matthew Bax), #2 DIVINNE MAGIC (Samuel Fillion), #3 WARAWEE YAMA (Nick Boyd), #5 SISTER TWISTER (Tyler Borth) and #8 ANGELIKI (Doug Brown) concerning the extended breaking rule; no violations of the breaking rules by these horses.
