

Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

• Early Veterinary scratch (sick) of WALKOFF Z TAM from the seventh race; this horse is entered on the short term (seven days) veterinarians list.

Races:

- 1. Start delayed as #2 HONEY BE FIRST (Pascal Berube) required a chin strap adjustment after which the #4 SKY SPIRIT (Richard Simard) broke the crupper. Clear.
- 2. Discussed race pace (31¹ 104¹) with the driver of #4 AMANDUS, Jimmy Gagnon; considering the explanation of Mr. Gagnon, the class (maiden trotters) and that the following horses were not impeded, no regulatory action is required. Clear.

- 4. The #4 HETTIES MAGIC (Jimmy Gagnon) suffered broken equipment (buxton) after the ¾ mile pole, subsequently broke (charted with an equipment break) in the stretch and finished with broken equipment. Clear.

- 8. Late Judges scratch (transportation) of CAMLACHIE CHROME; refund: \$80.

Inquiry on the performance of #1 DELCO DYNAMO (Stephane Pouliot), who broke before the ¾ mile pole and finished third; after reviewing the video it was determined that there were no violations of the breaking rule.

Reviewed the break by #4 FREE VERSE (Robbie Robinson) after the start; while off stride #4 did cause interference to #5 YOU GOT THIS (Ryan Guy); #4 finished sixth placed seventh (AGCO rule 22.09). The #4 suffered broken equipment (knee boot) while off stride and finished with broken equipment. Clear.

- 9. Reviewed the break by #4 CROSSFIT (Jimmy Gagnon) who broke after the start and finished third; no violation of the breaking rules.
- 10. Delay due to a problem with the parimutuel system and a further delay as the #6 TALKIN AGAIN (Robbie Robinson) would not turn. Driver of #9 PERFECT DALIANCE, Mike Healey, was cautioned regarding his urging in the stretch. Clear.
