

Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Early Judges scratches (ineligible) of WALKOFF Z TAM from the first race and LAA DEE GAA from the seventh race.
- Early Judges scratch (other) of QUIVERS HANOVER from the first race.
- Early Judges scratch (transportation) of INCREDIBLE HALL from the seventh race.
- Review held with driver Mike Healey concerning driving up on another horse in the first race on 2 October while driving #2 MAJOR MOTION. The explanation of Mr. Healey was partially accepted and no regulatory action is required although he was cautioned to keep a safe distance from the horse in front.
- Official warning entered on the licence of Gary McDonald concerning AGCO rule 26.14 (eligibility of horse).

Races:

- As there were only three starters, fourth and fifth place monies were retained by the Association (AGCO rule 18.02). Clear.
- 2. Driver of #2 A BLACK DIAMOND, Stephane Brosseau, was cautioned regarding his urging in the stretch. Clear.

- 4. Recall as #5 FREE VERSE (Robbie Robinson) had broken equipment (side hopple hanger). Clear.

- 6. Reviewed the break by #5 LOCHABER (Robbie Robinson) after the ¾ mile pole; while off stride #5 did cause interference to #4 PARTY VIBES (Guy Gagnon), #8 MASTER FENCER (Jimmy Gagnon) and #9 SIR LUCKNOW (Pascal Berube); no placing necessary as #5 finished ninth (last). Clear.
- 7. As there were only four starters, fifth place monies were retained by the Association (AGCO rule 18.02). Clear.
- 8. Late Veterinary scratch (sick) of BETTIMONTHERIVER; refund: \$164; this horse is entered on the short term (seven days) veterinarians list. The driver of #7 HOWMACFIESTY, Stephane Brosseau, will attend a review regarding his urging in the stretch. Clear.
- 9. The #3 FITT BITT (Anne-Marie Turenne) suffered broken equipment (trotting hopples) after the ¼ mile pole and finished with broke equipment. The #1 LESTENPERCENT (Guy Gagnon) broke before the ½ mile pole and qualifies for breaks in two consecutive races on a fast track (trainer notified). Clear.
