- Received two Certificates of Positive Analysis from 23 October for arsenic above the allowable limit of 300 ng/mL for trainer Matthew McDonald who was informed by telephone and will attend the Judges Office Sunday 6 November to receive disclosure:
 - Race 5 YS MATHIS (EIPH) (9RM61) finished first; test card number 4522296302 quantified at 1083 ng/mL.
 - YS MATHIS is entered on the Judges list and is ineligible to be entered or race for a period of thirty (30) days (3 November to 2 December 2022, inclusive) per AGCO rules 9.07.01(iv) and 20.01.01(j); a certificate of analysis quantifying arsenic level for this horse below 300 ng/mL is required to reinstate horse eligibility (Number 1937574).
 - Race 6 SUNNY BO (EIPH) (4PM78) finished first; test card number 4522296304 quantified at 845 ng/mL.
 - SUNNY BO is entered on the Judges list and is ineligible to be entered or race for a period of thirty (30) days (3 November to 2 December 2022, inclusive) per AGCO rules 9.07.01(iv) and 20.01.01(j); a certificate of analysis quantifying arsenic level for this horse below 300 ng/mL is required to reinstate horse eligibility (Number 1937576).

- Matthew McDonald is fully suspended as of 3 November (AGCO rule 9.07.01(ii)) pending the disposition of an investigation relating to Certificates of Positive Analysis for SEA LAIRD (Tag #452228915), YS MATHIS (Tag #4522296302) and SUNNY BO (Tag #4522296304) (Number 1937541).
