Ruling #2091623 generated – “Colossal Faith” is hereby ineligible to race in Ontario for 30 days, March 17 to April 15, 2023 (inclusive). As per AGCO rule #9.07.01(iv).

Race 1 - Clear

Race 2 – “Inquiry” before the start #4 “Jackie Davis” (Harris 8th) gets running in and makes a break in stride on her own. Interference charted on #5 “Anchor So Reel” (Clements 1st) before the start, but was the race winner, no refund required.
