- Mr. Marfisi was notified by phone and will pick up his disclosure package tomorrow. He was informed that any horses that leave his care will require an approved AGCO trainer transfer.

- Ruling #2148591 – The horse Laz is placed on the Judges List and ineligible to race in the Province of Ontario for 30 days, April 28 – May 27/23, inclusive. AGCO Rules 9.07.01(iv) & 20.01(j).

- Kyle Fellows picked up his disclosure package this evening.

- Approved trainer transfers from Joshua McKibbin to Francis Guillemette on the horses Mc Kella and Final Dream.

- In Race 7, #3 Odds On Checkmate was programmed with the wrong driver/trainer. It was corrected to Driver Travis Cullen and Trainer Russell Ellis.

Race 6 – Reviewed racing around the final turn – #3 Baby Bonita (Sylvain Filion) was charted with interference due to #2 Golden Leader (Doug McNair) slowing up and running out into his path around the turn. No placings needed.

Race 8 – Inquiry – Reviewed racing in the stretch between #3 Got The Gold (LP Roy) and #8 Raptors Won (Sylvain Filion). The front tower shows #8 is advancing to the outside of #3, but is running in and Filion must correct his horse to avoid hooking wheels with #3 from behind. The Panel did not feel #3 caused interference to #8. No placings needed.

Race 9 – All Clear

Race 10 – Reviewed racing in the stretch – Colin Kelly makes multiple attempts to keep the rail closed, but #6 So Frisky is visibly bearing out and the winner, #2 Mystifying (Doug McNair), passes on the inside. Mr. Kelly was not in violation of AGCO Rule 22.05.01(e).

- Reviewed the 2nd quarter (:27, :58.4) – #10 Snow Shark (Travis Cullen) is on the lead and #6 clears to the front at the 3/8ths. Judges spoke to Cullen about maintaining a pace comparable to the class. There is a strong headwind down the backside and given the track/weather conditions, the Judges accepted Mr. Cullen's explanation and did not feel a penalty was warranted for AGCO Rule 22.05.01(k).
