The U.S. Trotting Association (USTA) announced on Thursday, June 1 that, as the result of recently reported issues with the sulky model Spyder 3D and after a detailed investigation held by the USTA, in cooperation with the sulky manufacturer, the decision has been made to withdraw it from the USTA Approved Sulky list, effective immediately.

Furthermore, AGCO Standardbred Rule 22.21.04 states "Use of bent shaft sulkies in any race is prohibited. Only USTA approved conventional sulkies will be permitted to be used."

Therefore, Spyder 3D sulkies are not permitted in Ontario.
