

Clear.

The #1 BBC SPORTSBOY (Marc Belanger) suffered broken equipment (shoe) after the start and finished with broke equipment.

- 2. The #6 BEST HONEY HANOVER (Pascal Berube) suffered broken equipment (shoe) after the ¼ mile pole and finished with broken equipment. Clear.
- 3. Clear.
- 4. Start delayed as #9 MOONLIGHTBOY (Samuel Fillion) lost a shoe in the parade. Clear.
- 5. As there were only four starters fifth place money was retained by the Association (AGCO rule 18.02). Reviewed the performance of #4 DONATOVER (Stephane Brosseau) who broke before the ¾ mile pole; while off stride #4 did cause interference to the race winner #5 BLACK TIE BASH (Robert Shepherd); no placing necessary.
