

#### Office:

- Trainer transfer application for STELIOS (2N623) from Matthew McDonald to Richard Moreau is not approved. The new owner of this horse, Anne-Marie Turenne, attended the Judges office along with COSA President Bill O'Donnell (by telephone) to discuss this decision. Ms. Turenne has provided documents to support the request which will be considered.
- Early Judges scratches (other) of POWERCHICK from the first race and WATCH HER GO from the sixth race.
- Early Judges scratch (injured) of MCKEE SEELSTER from the sixth race.
- Early Judges scratch (transportation) of CALL HER KONTIKI from the eighth race.

- 4. Late Judges scratch (other) of #5 JD MAGIC MOON; refund: \$991; the trainer of this horses was adjudged guilty of violating AGCO rule 17.17 (withdrawing a horse without permission) and assessed a monetary penalty of \$200 (Number 2213727). Clear.

- 7. Reviewed racing in the stretch between #3 DREAMFAIR BJ (Mike Healey), who finished sixth, and #8 ASSASSINS CREED (Jimmy Gagnon), who finished seventh, concerning possible interference; #3 and #8 may have brushed wheels but neither was impeded; no violations.
