Race 9 – Inquiry – Reviewed racing at the 3/4s and stretch for a possible pylon violation by #8 Taurasi (Doug McNair), finished 3rd. The video shows #8 races inside four consecutive pylons after the 3/4s and two consecutive pylons in the stretch – it was ruled that #8 was forced inside the pylons for safety reasons both times #3 Buzzsaw Russ (Yannick Gingras). As a result, #8 was not in violation of the AGCO pylon rule. #8 was charted with interference after the 3/4s and in the stretch.
