Race 2 Reviewed the break of #5 We Meet Again (Filion) before the ¾ pole. Interferences charted to all trailing horses; no placing required. Spoke to T. Ratchford about trying to keep the hole filled in front of him.

Race 3 Judges spoke to both Dan Obrian and Gino Toscani about their urging. Both were issued warnings about using more than acceptable wrist action. Waring were put on both their records.

Race 6 Reviewed the break by #3 Barstool Mountain at the 3/4, the horse made a break on its own and must qualify for 2 consecutive breaks on a fast track.

Race 7 Katkin Maorgan made a break and then the head check came off. Finished with broken equipment.

Race 8 Inquiry X2.

Inquiry #1 in the stretch. #5 Right Mach (Filion) and #8 Blinded By The Light (Phil Hudon) hooked wheels. #5 was wanting to come through a tight spot and thought his room was taken away by #6 Catch My Breath (B.
