Reviewed the break by #4 ORLYS ANGEL (Pascal Berube) after the ¾ mile pole; while off stride #4 did cause interference to #6 KINNDER FIRSTCLASS (Stephane Pouliot) cause this horse to break (charted with an interference break); #4 was off stride for more than 25 consecutive strides, finished seventh placed ninth (last) for an extended break (AGCO rule 22.27.02).
